I hereby undertake that:

1. The Minor has my consent to stay at the Hotel during the Period unaccompanied.
2. I have impressed upon the Minor (i) the requirements set out in the “Designated Hotel as Quarantine Facilities to the Department of Health Information Sheet”, as well as (ii) the applicable statutory requirements and other requirements of competent authorities, and required him / her * to observe and comply with them during his / her * stay at the Hotel at all times.
3. I shall be responsible for the acts, neglects, omissions and defaults of the Minor as if they were mine and shall indemnify the Company, The Prince Hotel Limited and their officers, employees and agents (“**the Indemnified Parties**”) and keep the Indemnified Parties indemnified against any and all loss, damage, injury, claim, demand, action, legal proceedings, cost or expense caused by the Minor during his / her * stay at the Hotel.
4. Save as a result of the willful default or gross negligence of the Indemnified Parties, the Indemnified Parties shall not in any circumstances be liable, and I shall on behalf of the Minor hold harmless and release the Indemnified Parties from any and all liability for any loss, damage or injury which may be sustained by the Minor during or as a result of or in connection with his / her * stay at the Hotel.
5. Please provide a clear scanned copy or photocopy of the father / mother / guardian * HKID card as a verification of the signer’s identity (Date of birth should be covered or truncated).
6. Hotel may call directly to the father / mother / guardian * for further verification if required.
